COMCRIM is an interdisciplinary research project conducted by an international public-private research consortium into crimes that undermine democracy and the rule of law in and via the Netherlands (*ondermijning*). Over 28 scholars from more than nine disciplines jointly examine the systemic factors of organized crime. Public and private partners collaborate to detect such crime in unconventional data sources such as banking records, follow the money and discern criminal networks, patterns, and effects.
